# Statistical Consulting in the Pharmaceutical Industry

#### **David Underwood**

**Abstract:** The talk will reflect on 20 years of consulting experience, and examples of real life situations will be given, however names and circumstances will be changed to protect the innocent!! Examples drawn from consulting as a company statistician from within a major pharmaceutical company will be contrasted to those when acting as an external consultant. The effect of the statistical review from within the UK regulatory authorities on statistical consultants will also be discussed.

**Speaker:** David Underwood joined Smith Kline and French in 1978 as a statistician. Since then he has had considerable experience in the pre-clinical, clinical and post marketing areas, designing and analysing many types of studies ranging from toxicological experiments to large European multicentre clinical trials. He has also advised on studies as diverse as trials involving single patients and large epidemiological studies based on the Third World. David was Head of Clinical Data Management Services responsible for 30 Data Management and Statistical staff when he left SmithKline Beecham in 1994 to set up the STATWOOD Partnership with John Beresford. David is a Chartered Statistician and was awarded his MSc in 1978.
